Dear Handball Friends,

The draw for the Men's EHF EURO 2022 Qualifiers Relegation Round matches took place on 23 July 2019 in the EHF Office, Vienna, Austria. These matches will be played in home and away match in the National Team week in October 2019 or in the National Team weeks in January 2020. The winners of the Relegation Round matches will qualify for the Men's EHF EURO 2022 Qualifiers starting with round 1 in October 2020 and finalising with round 6 in April 2021. The final tournament in HUN/SVK will be from **14 to 30 January 2022**.

ORGANISATION

The first priority regarding each match is with the playing day and the venue, while the exact throw-off time can still be fixed in a later step. Please fill in and send us back the attached "Match information" form. We kindly ask you to use only the attached EHF Match information form! Please remember that it is mainly in the interest of all the participating Federations to have fixed the most important details of match as early as possible and we therefore count on a positive co-operation in this issue by all parties concerned.

The national federations participating in the Relegation Round matches are kindly requested to provide detailed information on their planned playing hall for the home match. For the new halls (not already registered) please refer to the attached Hall Form and return it, incl. respective pictures to the EHF, Thomas Gangel: gangel@eurohandball.com

We kindly ask you to take note as the deadlines for the detailed match information regarding the matches in the National Team weeks in October 2019: **Monday, 2 September 2019** and in January 2020: **Monday, 14 October 2019**.

All six teams are also involved in the 2021 Men's World Championship Qualification phase 1. In case there will be a majority decision in the respective group to play the qualification matches in home and away format, the only possibility to play the Relegation Round matches will be: **Wednesday/Thursday, 15/16 January 2020 (1st leg)** and **Saturday/Sunday, 18/19 January 2020 (2nd leg)**.

The final decision in this regard will be communicated as soon as the playing format for all Men's World Championship Qualification groups is known (end of August 2019).

EHF OFFICIALS

The nomination of referees and delegates will be published in due time prior to the competition. The travels of referees and delegates will be organised by the EHF. All nominated delegates will receive special instructions regarding these games.

OFFICIAL SQUAD

The deadline for the Official Squad is on Mondays, nine days prior the playing period.
About the exact deadline we will inform you when the Relegation Round matches dates will be fixed.

QUOTA OF ADMISSION TICKETS

The home federation shall make available to the visiting federation 10% of the admission tickets against payment of the customary local price. The tickets shall be ordered in writing by the guest team not later than ten days before the match. Any tickets not ordered by then may be disposed by the home federation.

The EHF requests all parties involved to keep the deadlines in order to secure a correct and timely organisation of these matches. Any changes of organisational details after each deadline will only be accepted by EHF after careful investigation of the respective reason. Possible additional costs for any party concerned will be charged accordingly.
